ELECTION NOTICE NO. – 01. DT. – 08.01.2015.

Rules and procedure of the Election to the Executive Body of Students Union for the session 2014-15 is in accordance with the Vidyasagar University Regulation relating to the uniform constitution of the Students Union of the affiliated Colleges (other than Govt. College and the Colleges imparting instruction in Engineering and Technology and Medicine.)

1. Election of the **Students Union 2014-15** for the constituency of classes 1st year Arts, Science and Commerce, 2nd years Arts, Science and Commerce and 3rd year Arts, Science and Commerce. & MA 1st and 2nd Year.
2. Date of Election : **29.01.2015.**
3. Date of issuing nomination paper on : **16-01-2015 & 17-01-2015 between 11 a.m. to 2 p.m.**
4. Submission of Nomination Paper on : **16-01-2015 & 17-01-2015 between 11 a.m. to 2 p.m.** nomination papers issued by the election Commission after properly filling, are to be submitted by the candidates and proposers to the Election Commission and put their signature in Bengali & English before the Commission.
5. Scrutiny of Nomination papers will be held on : **19-01-2015 after 2 p.m.**
6. Date of publication of the list of valid Nomination papers (class-wise) in alphabetical order of the first name in English spelling on : **17-01-2015 after scrutiny.**
7. Date of withdrawal of Nomination papers on : **19-01-2015 between 11 a.m. to 2 p.m.**
8. Date of publication of the list of valid contesting candidates (class-wise) on : **21-01-2015 after 2 p.m.**
9. Date and hours of polling 29-01-2015 (11 a.m to 2 p.m).

The election will be held on **29-01-2015** as per schedule given below. A grace period of **15 minutes** may be allowed by the polling officers to enable students to assemble in the room allotted for different classes before polling actually takes place. Entry through the College gate only by the student voters before & within the grace period does not entitle him/her the right to enter the voting compartment and to vote. Under no circumstances the student voters will be allowed to enter into the voting compartment allotted after the expiry of the said grace period.

10. Counting of votes of all classes will be done in Room Nos. **17, 18 and 19** on the same day after the completion of the poll of all classes.
11. Declaration of result of election shall be made immediately after the counting is over.
12. In case two or more contesting candidates secure equal number of votes, none of them can be declared as elected. In this case of tie, decision will be made by drawing lottery on the spot i.e. where the counting is done by the polling personnel on duty along with the presence of at least one of the members of the Election commission.
